The Chair announced that the next regular meeting of the Planning Board would be held at Village Hall on October 9, 2024 at 7:30 pm.

The Board continued the public hearing with respect to Case No. 24-03rb Application of Toll Northeast V Corp., 1140 Virginia Drive, Fort Washington, PA 19034, by its agent, Daniel Masterson, 42 Old Ridgebury Road, Danbury, CT 06810, pursuant to Village Code §179-79, to reduce the principal amount of performance bond for compliance with conditions. The proposed reductions would reduce the bond amounts to less than 50% of the original required amounts. Premises are known as the Manhasset Crest subdivision and are designated as Section 3, Block 162, former Lot 822 on the Nassau County Land and Tax map, also known as 251 Searingtown Road, North Hills

The minutes of the hearing were stenographically transcribed, and are on file in the Village office. The applicant appeared by Jennifer Appel, Esq. After hearing all interested persons, the hearing was closed on motion by Ms. Kane, seconded by Mr. Schubert and adopted unanimously.

After discussion, on motion by Mr. Bassik, seconded by Ms. Struminger and adopted unanimously, the Board approved the application to the extent that the principal amount of the bond was reduced to \$201,250. The applicant shall submit a revised bond or bond endorsement to reflect the reduced principal amount of the bond.
